Highway Noise and Funeral Parking Problems Proposal

On March 11th Saanich Council voted unanimously to write to the Provincial Government to support the installation of noise mitigation measures along the Pat Bay Highway near Falaise Dr.

In February the FCA wrote to Saanich Council proposing a funding solution to solve both the highway noise and funeral parking problems our community experiences. On March 11th we presented our case at a Saanich Council meeting and Council voted to support our request.

Because the highway is physically close to Falaise Drive with its funeral parking problems, we thought the funding solution to both problems might be the 2014 New

Canada Building Fund (NCBF). This fund provides money for projects that "improve the environment and support stronger, safer communities". We believe our issues fall into this category and, because Saanich does not appear to have previously accessed this fund, we thought this might be a good project for Saanich to support. Saanich will likely contribute to the project by widening parts of Falaise Drive to improve street parking; a project that might be paid for by accessing the Gas Tax Fund.

With Saanich's support, it is now up to the Ministry of Transportation and Infrastructure to prioritize the application to the NCBF. Our MLA, Lana Popham, has previously promised to help us with this issue and we expect she will be working with her colleagues to get this done.

Falaise at Royal Oak Intersection Updated

By now you will have noticed the new lights and wider sidewalk at Falaise Dr. and Royal Oak Dr. They were installed in response to the Falaise Community Association asking Saanich to improve safety for pedestrians crossing Royal Oak. Now pedestrian walk signals do not coincide with left turn signals for vehicles and accessibility has been improved for mobility-impaired pedestrians and people in wheelchairs.

Falaise Park Restoration Update

We have continued to make progress, thanks to two work parties. In late January we planted the native plants (notably Oregon grape, ferns, salal and flowering shrubs) along the eastern boundary fence near the playground. This was before the late snowfall so hopefully they survived the cold snap and will bud out soon in the spring warmth.

We also planted six Garry oak seedlings on the slopes of the Garry oak meadow (near the park sign). You'll notice them in their protective wire cages. Saanich Parks will be watering them regularly during the summer.

In late spring, watch for the flowering of camas lilies under the oak trees in the meadow. One of our long term goals is to weed out all the invasive orchard grass that is crowding out the camas lilies so that the flowering can become even more spectacular.

Our work parties will be continuing though until June. The dates will be posted on the FCA website. Our weeding efforts will focus on pulling the English ivy and blackberry under the trees on the north boundary beside Falaise Crescent and around the perimeter of the playground.

Subdivision Postponed

The Lot 855 proposal was on the agenda of the March 4th meeting of the Committee of the Whole of Saanich Council. Several residents gave five-minute presentations while the FCA Executive was permitted to make a ten-minute presentation.

Some were concerned about the loss of the Garry oak trees, while others were not happy with the large size of the proposed houses. They considered them to be out of character with the neighbourhood and would likely lead to significant on-street parking in that area. No one spoke in favour of the rezoning and subdivision.

Council voted to support a motion to postpone a decision on the rezoning and asked the developer to come back with a new proposal that would be more acceptable to the community. It was suggested that this might include saving more Garry oaks and building smaller houses.

The Mayor commented on the large turn-out from the community which he saw as an expression of neighbourhood concern. He pointed out that, if the property is not rezoned, a monster house of up to 10,000 square ft could be built on the property.

We will add any new information on the status of this application to the website as it becomes available.

Subdivision Background

Recently, a new owner bought 855 Falaise Crescent, which shares a common boundary with Falaise Park. The owner is proposing to rezone and subdivide the lot into two narrow lots. The developer submitted detailed plans to Saanich Council which include cutting down four large Garry oak trees and building two large houses.

The FCA, as well as local residents, prepared written submissions regarding the plans.


