#### 1. Minutes

Two changes to the minutes were proposed. Stuart asked that his apology for his absence be noted. Bob pointed out that he had agreed to draft a policy statement regarding the FCA position on Lot 855. Carl will make the changes. Bob moved, Carl seconded, that the minutes be accepted. All in favour.

#### 2. Financial report

Sandrine now has the LibreOffice spreadsheet working and was able to generate a complete financial statement. She sent all directors a copy of the summary. She pointed out that there was no obvious place to file the two recent cheques for consulting services. It was agreed to file them under "miscellaneous" with a comment. The number of members was not filled in but the dues seemed lower than expected. Mac pointed out that he has a significant sum of money that he needs to get to Sandrine. Bob pointed out that we have now received our operating grant from Saanich. Carl moved, Bob seconded, that the financial report be accepted. All in favour.
