## 2. SCAN April 5th Meeting-Review by Terri.

Brief overview of the meeting, with an insight of the work including zoning concerns and challenges of other community associations. Copy of the this SCAN's meeting agenda is enclosed,incl. the density bonus topic by UVIC Law Professor Deborah Curran.

Katherine Burgess and a colleague from Megson Fitzpatrick Insurance Services handed out copies of the enclosed "Directors and Officers Liability Insurance" brochure to all attending the SCAN meeting, copy attached. We (Terri, Bob and I) were disappointed in that there was no presentation by these Company reps on their Insurance plan(s), associated costs, and pros and cons for directors' liability insurance. (After the meeting we gleaned more about this topic from Bob Isbister- Broadmead Community Association, and concerns incl. such concerns re—Defamation by members).

Next steps -FCA Exec. to review and discuss the attached Brochure, and further to this: possibly have further discussions with other Community Associations with experience so that we can make an informed decision on this serious topic. Terri to sound out SCAN re: the possibility of obtaining a group rate from MegsonFitzpatrick for Directors' Liability Insurance.

Terri asked the SCAN group about the frequency/practice of their Treasurer Report up-dates to the Executive during the fiscal year. A number reported that they had Treasurer up-dates at each Exec. meeting, with a final report at the AGM.

# 3. Constitution- Review and Action Plan

Terri passed on to us a copy of the Royal Oak Association Constitution, with Gordon Head and Camosun posting theirs on-line which we will review. However the FCA are really looking for "Generic Guides" from SCAN(who should really be providing this direction), which we can use in the compilation of our FCA constitution. However, the FCA, regardless will finalize the revision of the up-dated constitution during our 2017 term of office. (As we are all aware Bob had already submitted to the Government our up-dated constitution, however we want to revise this to a more pragmatic document during our 2017 term of office for future FCA members as well).

Bob had a quote from MegsonFitzpatrick of \$650 with a quote to follow from Coast Capital re; Liability Insurance .

#### 4. Crematoria Report by Bob

To date Bob has not found any provincial regulations, or anything under the BC Environmental Management Act regarding criteria on crematorium aspects such as impacts on the community re: odour and other critera. Bob to review further with Saanich, and Dale with Work Safety.
